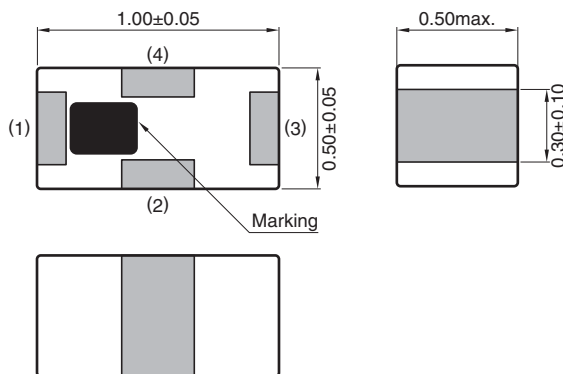

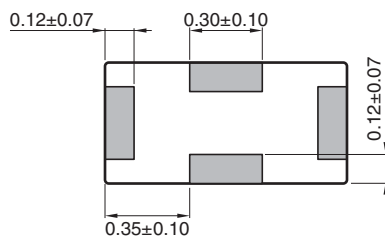

[Bottom view]

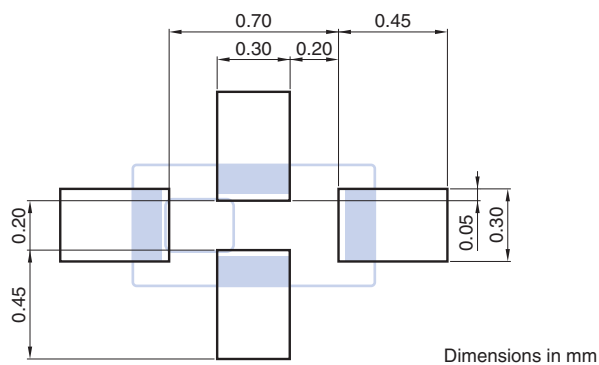

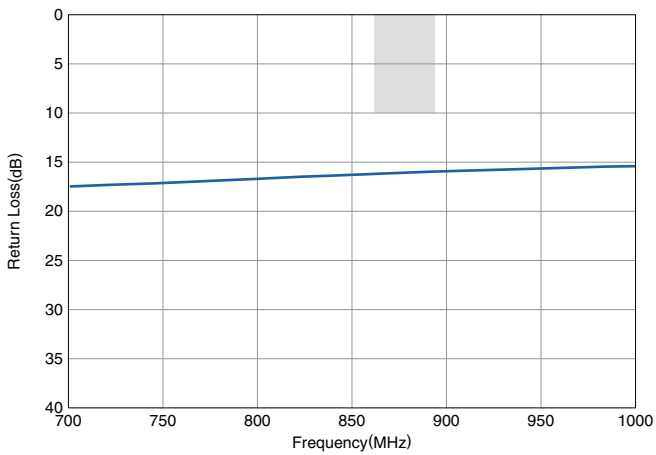
### INSERTION LOSS



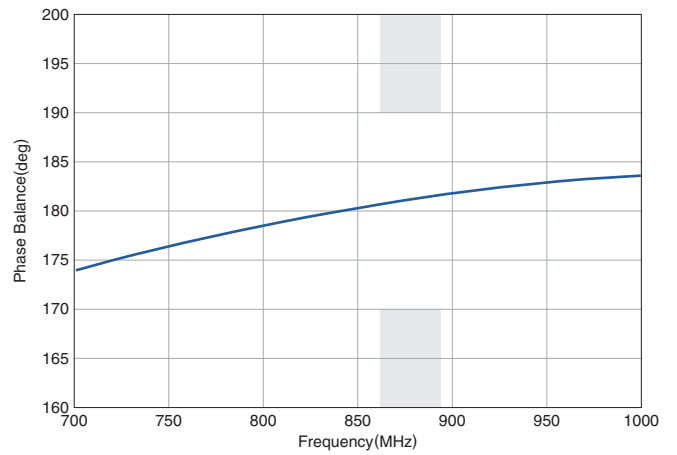
### AMPLITUDE BALANCE
